In these times of lean budgets and increasing levels of poverty, it is important to support programs that have evidence-based, positive outcomes for the working poor.

Providing quality child care is such a program that has proven, positive outcomes for children and the larger community. When young children spend their first years with nurturing adults in a high-quality, developmentally-appropriate setting, they accomplish more in school, parents perform better at work and our State saves money. Every dollar invested in high-quality child care returns at least \$7 in tax savings due to the need for fewer services, such as special education.

The Public Policy Committee of the Diocese asks all parishes to participate in the *Public Policy Weekend ~ February 9-10, 2013* which focuses on the need for increased funding for quality child care subsidies.

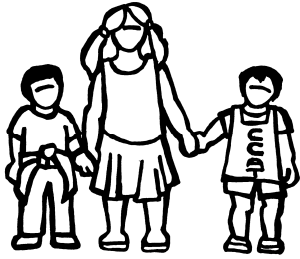

**Week #1 December 30, 2012**

**Children are our present and our future. They are a sign of God's continual gift to the world. Let's make good choices for children.**

This weekend the Catholic community celebrates the *Feast of the Holy Family*. Our love for Jesus leads us to speak up for children and families in our community who may need our help, especially working families in poverty. The Diocese of Rochester Public Policy Committee invites us to advocate for increased state funding for high-quality child care, so that working parents have help paying for safe, quality care for their children while they are at work.

**Week #2 January 6, 2013**

**Children are our present and our future. They are a sign of God's continual gift to the world. Let's make good choices for children.** In New York State, 18.9% of children under age 18 are growing up in families with annual incomes *under* the federal poverty level (\$23,050). A parent working full-time at minimum wage (\$7.25) earns \$15,080 annually. This makes it very difficult for many working parents to afford high-quality child care. For example, the average monthly cost of high-quality child care for a pre-schooler is \$688 (\$8,256 annually for one child) in Seneca, Chemung, Schuyler and Tioga Counties; infant childcare in Monroe County is \$1,000 (\$12,000 annually).

**Week #3 January 13, 2013**

**Children are our present and our future. They are a sign of God's continual gift to the world. Let's make good choices for children.**

Many working parents need help paying for high-quality child care which can cost more than \$8,000 annually for a pre-schooler in our region of the state. 75% of a child's brain growth and 85% of intellect and social skills develop before age 5. These first years are critically important for children and it is important that we help parents afford high-quality child care. Our parish will join with the Diocese of Rochester Public Policy Committee and other parishes on the weekend of February 9-10, 2013 to *ask Governor Cuomo and the New York State Legislature to invest \$300 million to provide subsidies for high-quality child care for children in low-income families in New York State.*

**Week #4 January 20, 2013**

**Children are our present and our future. They are a sign of God's continual gift to the world. Let's make good choices for children.** Funding for high-quality child care in New York State has declined in recent years. In 2002, there were 12,261 children in Monroe County receiving childcare subsidies, by 2012 that had dropped to 7,493; Steuben County 660 in 2002 and only 250 in 2012; Chemung County 1,335 children in 2002 and 607 in 2012. When child care assistance is cut, low-income working parents are often forced to choose between quitting their job or placing their children in less-than-desirable child care situations. Parents without after-school care miss, on average, 8 days of work per year because of the unpredictability of their child care arrangements.

**Week #5 January 27, 2013**

**Children are our present and our future. They are a sign of God's continual gift to the world. Let's make good choices for children.**

Government funding for high-quality child care has been cut by about 45% during the past ten years. Investing in high-quality child care benefits the economy - each new dollar spent in the child care sector generates \$2 in other economic activity immediately; and, every dollar invested returns long-term \$7-\$17 in tax savings due to the need for fewer services, such as special education. Research demonstrates that children in low-income families who participate in high-quality child care accomplish more in school.

**Week #6 February 3, 2013**

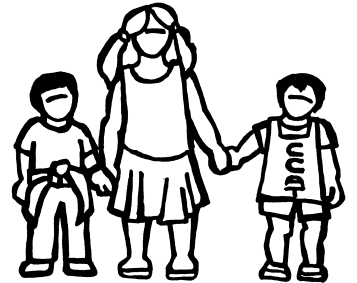
# Investing in Our Future: Supporting Quality Child Care

## Diocese of Rochester Public Policy Weekend, February 9-10, 2013

*Research has long shown that young children do best in school and life when they spend their first years with nurturing adults in a high-quality, developmentally-appropriate setting. Yet without government subsidies, this kind of quality child care is far too expensive for many working families.*

### Are we making sure that all children have access to safe, quality child care?

- Last year's New York State budget included \$92 million in state funds to offset federal cuts in child care subsidies. However, even with this critical investment, child care funding in New York is lower than in the past.
- Because of inadequate funding, fewer than 38% of working families in **Steuben County** who are seeking child care subsidies will receive this assistance in 2013. In 2002, there were 660 children receiving subsidies; by 2013, that number will drop to approximately 250.
- 2002 in **Chemung County** 1,335 children received subsidies; in 2012 only 607; currently there are 672 children on a waiting list for child care subsidies.
- Because of inadequate funding, fewer than 40% of working families in **Monroe County** who are eligible for child care subsidies receive this assistance. In 2002, there were 12,261 children receiving subsidies; by 2012, that number had dropped 7,493.
- New York State was named the least affordable state for Center-Based Infant Care in August 2012. The average cost of one year of high quality infant care in New York is \$14,009.



### Are we making sure that kids get what they need early in life to grow up healthy and successful?

- 75% of brain growth and 85% of intellect, personality and social skills develop before age 5 - before a child ever steps foot in Kindergarten. Those first 2000 days of a child's life - from birth to Kindergarten entry - are critically important and impact their success in school and in life.

### Are we strengthening our workforce and economy?

- When child care assistance is cut, low income working parents are forced to choose between two undesirable options - either quit their job or place their children in substandard care.
- State investment in quality child care pays significant dividends in the well being of children, families, communities, and the economy.

## **Homily Helps**

February 3, 2013-- 4<sup>th</sup> Sunday of Ordinary Time

Our responsorial today psalm proclaims:

"On you I depend from birth; from my mother's womb you are my strength."

All life, from the womb to the end of life is a gift of God and depends on human nurturing. Our Catholic tradition calls upon us to support the gift of life before and after birth if we are to be consistently pro-life. Our focus on caring for children with quality child care shows that we will not abandon children, but will nurture them to reach their full human potential.

Research has long shown that young children do best in school and life when they spend their first years with nurturing adults in a high-quality, developmentally-appropriate setting.

75% of brain growth and 85% of intellect, personality and social skills develop before age 5 - before a child ever steps foot in Kindergarten. Those first 2000 days of a child's life - from birth to Kindergarten entry - are critically important and impact their success in school and in life.

Yet without government subsidies, this kind of quality child care is far too expensive for many working families, as high quality child care can cost up to \$14,000 per year.

Our State benefits as well. Every dollar invested in high-quality child care returns at least \$7 in tax savings due to the need for fewer services, such as special education.

As Marian Wright Edelman, from *The Children's Defense Fund*, says: "The question is not whether we can afford to invest in every child; it is whether we can afford not to."

February 10, 2013-- 5<sup>th</sup> Sunday of Ordinary Time

Our responsorial today psalm proclaims: "forsake not the work of your hands."

The gift of a child is one of God's "works" which he will not forsake. Yet too often in our world children are aborted, forsaken, and abused. We know that it takes many resources and much love to raise and educate a child from infancy to young adulthood. Some families have fewer resources and therefore need help from others to pay for quality child care so the parents can continue working. Kashina is one of those parents.

Kashina Amons is a child care provider who can't afford to send her infant son to the center where she works - even with an employee discount. The full price of infant care at Jefferson Avenue Child Development Center where Amons works full-time, is \$1,000 a month. Employees are charged half price. But that's still out of reach for Amons, whose take-home pay is only \$800 a month.

Kashina Amons has taken a second job to earn more, hoping to be able to enroll her son in the center. "He needs to have the interaction with children so he could understand how to share," she says. But working more hours gives her less time with her son.

You can help parents like Kashina by signing the petition from the Diocesan Public Policy Committee after Mass. This petition asks our elected leaders in Albany to invest in our children by funding quality child care for the working poor.
