This Advent, this very week, please join your voice with the other Catholics in showing your solidarity with immigrants. Two very important things to do:


Stand with the Dreamers

Undocumented people who were brought to this country as children are known as "DREAMers", after the "Development, Relief and Education for Alien Minors Act", a bill that would give them a path to U.S. citizenship. For many years these brave young people, along with the Catholic Church and many other people of good faith, have advocated for passage of this legislation.

The wait must seem endless for people who grew up here and see America as their homeland but still aren't sure if they will be allowed to stay.

The Supreme Court will be ruling in June on DACA (Deferred Action for Childhood Arrivals); this program created by executive order gives 800,000 DREAMers the legal right to remain. However if the Court rules against it, the DREAMers could face deportation.

That's why there is an <u>urgent</u> need for the U.S. Senate to do as the House of Representative has done, pass legislation to give the DREAMers legal status and a path to citizenship. Speak Up for Immigrants Becoming U.S. Citizens

The U.S. Citizenship and Immigration Services is proposing major increases in fees to apply for asylum and for other immigration applications, and the elimination of many fee waivers granted to low income immigrants. For example, the fee to apply to become a naturalized citizen would go up from \$640 to \$1170!

From *the Catholic Legal Immigration Network*: "Raising prices and eliminating waivers make applying for vital immigration benefits

harder for low-income immigrants. The sharp increase in fees for naturalization and adjustment of status will likely deter immigrants from naturalizing or adjusting status, and increases in DACA renewal fees will further disadvantage young immigrants. Additionally, the imposition of a fee for affirmative asylum applicants places yet another burden on some of the most vulnerable people in the world... [T]his proposed fee schedule will eliminate most existing fee waivers. This, too, increases the burden on particularly vulnerable non-citizens seeking immigration benefits.

Immigration benefits should remain accessible, regardless of an immigrant's socioeconomic background. Join CLINIC in standing up for our immigrant brothers and sisters by opposing USCIS's proposed fee schedule increases."
