CASE MANAGEMENT ORDER RESCHEDULING FINAL HEARING ON FIRST DAY MOTIONS

On September 12, 2019, the Court held a hearing on Chapter 11 first day motions (ECF Nos. 8, 9, 10, 12, 13) and on September 19, 2019, the following Orders were entered on the Court's docket:

- 1) Interim Order Authorizing Debtor to (A) Pay Prepetition Compensation and Reimbursable Employee Expenses, (B) Pay and Honor Medical and Other Benefits and (C) Continue Employee Benefit Programs (ECF No. 42)
- 2) Interim Order (I) Authorizing the Continued Maintenance of the Debtor's Protected Self-Insurance Program; and (II) Authorizing the Payment of Certain Prepetition Obligations in Respect Thereof and Other Legacy Claims (ECF No. 43)
- 3) Interim Order (A) Prohibiting Utility Companies from Altering, Refusing or Discontinuing Service on Account of Prepetition Amounts Due, (B) Determining Adequate Assurance of Payment for Post-Petition Utility Services Under 11 U.S.C. § 366, and (C) Establishing Procedures for Determining Adequate Assurance of Payment (ECF No. 44)
- 4) Interim Order Authorizing, But Not Directing, the Debtor to (I) Continue Using Existing Bank Accounts, Banking Practices and Business Forms and (II) Maintain Investment Practices (ECF No. 45)

A final hearing on first day motions was scheduled for October 10, 2019 at 1:00 P.M. On September 26, 2019, the United States Trustee filed notice of the appointment of a Committee of Unsecured Creditors. (ECF No. 68). Debtor's counsel contacted the Court to indicate that proposed counsel for the Committee of Unsecured Creditors has asked for a postponement of the final hearing on first day motions so that committee counsel has adequate time to get up to speed

on the case. Debtor's counsel also indicated that the UST has not taken a position with respect to the postponement request. It is therefore,

ORDERED, that the final hearing on first day motions is rescheduled from October 10, 2019 at 1:00 P.M. to **October 24, 2019 at 1:00 P.M.** Any objections or responses to the first day motions shall be filed on or before **October 17, 2019 at 4:00 P.M.** and served on all parties in interest as required by the Federal Rules of Bankruptcy Procedure.
