

Join with others during the Season of Creation to call on the World Bank to **divest from fossil fuels**.

"The World Bank manages and invests huge amounts of public money in development projects. We need them to get all their money out of dirty fossil fuels [coal, oil and natural gas] and into affordable renewable energy to reach and benefit even the most vulnerable and remote communities.

This would have a huge financial impact and set a gold standard that other public and private banks would then aspire to.

The World Bank agrees that climate change is affecting the poorest people on the planet. Its goal is to end extreme poverty globally within a generation. However, it still supports a lot of projects that contribute to climate change. The World Bank needs to put its money where its mouth is.

We are calling for much greater transparency about the impact of their investments in energy on the lives of ordinary women, men and children.

If the World Bank should divest from fossil fuel companies, how about us and our parishes?

"Since the publication of Laudato Si', every living person on the planet has been urged to consider how we choose to engage in the world we see unfolding under the threat of the ecological and social crises.

Many faithful Catholics are commendably responding by moderating their consumption and embracing sustainable lifestyles including renewable energy technology. However, without careful attention to the way money is being invested, there is a strong possibility of unwittingly supporting the very practices that are degrading our planet."

We wouldn't want Catholic institutions making money off pornography or the manufacture of abortifacients.

We shouldn't want them making a profit off the destruction of the planet either.

It's easy to ask a giant institution like the World Bank to divest from coal, oil and natural gas; it's harder for us to figure out how we too can put "our money where our mouth (and our values) are."

Two Catholic colleges in the U.S. (Georgetown and the University of Dayton), a diocese in Italy, and several congregations of religious women are among the Catholic institutions that have already begun pulling their money out of fossil fuels. On October 4, more Catholic institutions are slated to announce they've made this decision to divest as well.
